HAS's intermunicipal emergency room is a collaboration between the municipalities of Heim, Aure and Smøla, and an ambulance boat is used in the collaboration. The shift load is currently 11-part shift, with the possibility of taking more shifts. This collaboration is currently in place, but will be phased out by the beginning of 2027 and replaced with another existing service (LiO).
